### C2013/2014.54 APOLOGIES FOR ABSENCE

#### C2013/2014.55 DECLARATIONS OF INTEREST

#### C2013/2014.58 MAYOR'S COMMUNICATIONS

- Balfour Beatty living places Attended a launch meeting on the 10 September. 90% of team have come across from Amey. All managers are new. All staff are undergoing training.

#### C2013/2014.59 BUTTER MARKET

Members received a presentation from Quarterbridge and considered referring the matter to Finance and Policy committee for detailed discussion.

The following was covered by Quarterbridge during their presentation:

- Quarter bridge leading developers for markets and improving and regenerating markets.
- In order for markets to succeed they need to be retailers and attract customers of all forms.
- Several (6 options considered) choices in relation to what could happen to the Buttermarket which have been considered for the most viable option.
- Should be a strong focus in the Buttermarket on food and drink and eating as these are all the things we need/do every day.
- Need to get into the mindset of shoppers. Markets need to be clean and bright and welcoming.
- Need to attract a wider demographic of shopper.
- A market needs to be run like a shopping centre to succeed.
- Interact with the community. Local food, improve local economy, passionate traders, knits the community.
- Guild hall in Buttermarket just used for storage at the moment but this could become a community hub, cooking school, arts and crafts school etc.
- Combine heritage of Buttermarket with modern retailing technique, New market layout, high standard stalls to name just a few.
- Quarterbridge have developed many award winning markets since 1999.
- Southport award winner for 2013. Used as case study in the presentation delivery.
- Plan of action:
- Design and specify the Buttermarket as a retail environment promoting local produce
- Ensure cost control and business plan adherence
- Pre- let space
- Encourage outsourced market management for the first two years
- Provide long term ownership options.

Bullet points from questions and answers are as follows:

- Examples of successful markets shown in the presentation have an entirely different population to Hereford. In the examples shown the populations are there to serve these markets in these areas which is not the case in Hereford.
- Outside markets challenge indoor markets due to rental costs.
- People will not carry produce brought from a market to their car which is parked a distance away.
- How would the above issues be addressed to make the Buttermarket successful?
- Main reason there are not enough traders in Buttermarket is due to the look and feel of the Buttermarket rather than the challenges from traders outside of the market.

- There is no viable way a bus service or parking area close to Buttermarket can be implemented so this is an issue that can't be overcome.
- The two markets at present trade as two separate entities and these need to trade as one and work together not individually - the outside market should be an extension of the indoor market.
- Where have Quarterbridge failed.
- Have not failed as yet.
- Whoever manages the markets needs to have control of both indoor and outdoor traders so they can be managed together as one.
- The City Council does not have the budgets or funding that Herefordshire Council have and so would be unable deliver such a costly project.
- The City Council should not consider taking on the Buttermarket unless it gets control of the outside markets as well.
- The City Council needs much greater detail before it could even consider taking over the Buttermarket.
- Past discussions about what people would like in the Buttermarket. A children's crèche in there would be ideal. Mothers often would use this service to enable them to go shopping for a couple of hours child free.
- There is no design for the Buttermarket at this stage until an appointment from the relative authority is received to proceed with designs and business plans. Crèches absolutely, a very good idea.
- Andrew Ashcroft gave a brief overview of past history and how Herefordshire Council have arrived at the point they are at today.
- Original plans were to develop the Buttermarket on a cost neutral basis but from the presentation there seems to be a completely different concept.
- A Herefordshire Council cabinet report refers to a decision needing to be made by December and this does not give enough time to consider this properly and deal with all the legal issues involved. This timescale is not practical.
- December deadline is for an idea of direction as it would not be possible to get all the legal issues by then.
- Proposed to pass consideration of this item to the Finance and Policy committee for more in depth consideration.
- o Importance of the Buttermarket.
- Hereford is in major transitional stage.
- The City Council to consider very carefully the options with the Buttermarket.
- Need to keep the historical centre of the City and think of ways to make this work and make the City Centre unique and bring people in.
- The Buttermarket needs to be made unique and is doable but it will need a real leap of faith to take this forward.
- Proposed to discuss this in detail and look at all over a dedicated 2 day period over a weekend.
- Possibility of the Buttermarket becoming a historical unit.
- Full consideration should be given to embarking on this project as a partnership with both councils taking a joint risk relative to each Councils size.

Cllr Toon proposed to discuss this in detail and look at all the information and detail over a dedicated 2 day period over a weekend.

Cllr Kenyon seconded Cllr toons proposal and it was put to the vote. 5 voted in favour of the proposal with 3 abstentions.
