3. CEREMONY

- 3.1** The Mayor will call upon the Town Clerk to read the Resolution of the City Council conferring the Honorary Freedom of the City to Peter Amor, as resolved at a meeting of the City Council on 6 December 2022.

“The City Council in exercise of its powers under section 249(5) of the Local Government Act 1972 confers the Honorary Freedom of the City of Hereford in recognition of the eminent services Mr Peter Amor has rendered to the City, being the most honourable distinction that is within the power of the City Council to bestow for distinguished service to the City’s economy, the brewing industry both locally and nationally, and recognising his significant contribution to local charities for many years”

- 3.2** The Mayor will call upon Councillor Jim Kenyon, proposer of the resolution, to speak.
- 3.3** The Mayor will ask Peter Amor to come forward to the dais.
- 3.4** The Mayor will ask the Honorary Recorder to read The Freeman’s Charge to Peter, then The Freeman’s Oath for him to repeat.
- 3.5** The Mayor will ask Peter to sign the Roll of Honorary Freeman.
- 3.6** The Mayor and Town Clerk will then sign the Roll of Honorary Freemen as witnesses.
- 3.7** The Junior Mayor will present the Freeman’s Scroll (a sealed copy of the Resolution) to the Mayor who will then present this to Peter.
- 3.8** Peter will return his thanks to the City Council.
- 3.9** The Mayor will congratulate Peter Amor, declare the meeting closed and will invite the assembled company to afternoon tea in the Mayor’s Parlour.
